Asthma

The Department provides outreach and education to families with children ages 1-18 years who have been diagnosed with Asthma and are currently experiencing issues with controlling it. Eligibility requires that children must be taking Asthma medication daily and have been recently hospitalized or visited the emergency room or missed many school days due to Asthma.

Lead Poisoning

In collaboration with the NH Division of Public Health, the Department provides Healthy Homes Assessment outreach and education to families with children that have documented elevated blood leads over 10 micrograms per deciliter.

Smoking

The Manchester Health Department provides residents with tobacco prevention and treatment information and materials, as well as connects residents with statewide tobacco resources.

The Weatherization Program can help to reduce your energy usage and heating costs by offering FREE Energy Saving Measures. Homeowners, mobile home owners and renters are eligible to apply. Eligibility is determined by income with priority given to elderly, handicapped, and families with children under 6. If your fuel assistance application lists your Federal Poverty Guidelines at or below 200% you qualify for weatherization.
